Biocides, Biocidal Products, and Treated Articles We Secure Placement on the Market

As of 2013, Regulation (EU) No. 528/2012 (EU Biocidal Products Regulation: BPR) covers the authorization and use of biocidal products, biocides manufactured in situ, and treated articles in the European Union. Because specific provisions apply to each of the three product types, the first step is to determine which category your product belongs to. We support you in this process and in complying with the related obligations.



Create Marketability and Safeguard Legal Security

Biocidal products are subject to complex notification and authorisation obligations and must comply with the provision of the BPR. We are familiar with the requirements profile for the individual product types, offer you comprehensive advice, and ensure the correct classification of your products so that their marketability is secured. Please note that biocidal products that contain existing active substances are subject to transition rules according to Article 89 of the BPR and must be electronically registered in Germany with the German Federal Institute of Occupational Safety and Health (BAuA) before their initial placement on the market. We can also handle this task for you.

Biocidal active substances are employed to protect human health. To ensure that they do not become a risk for the environment and human and animal health, the BPR specifies how to provide and use biocidal products. Of course, they must be classified, packaged, and labeled according to the CLP Regulation. However, Article 69 of the BPR requires additional information on the label. We can let you know what is required and what formulations are authorized. We also advise you about the concrete steps to take when advertising.

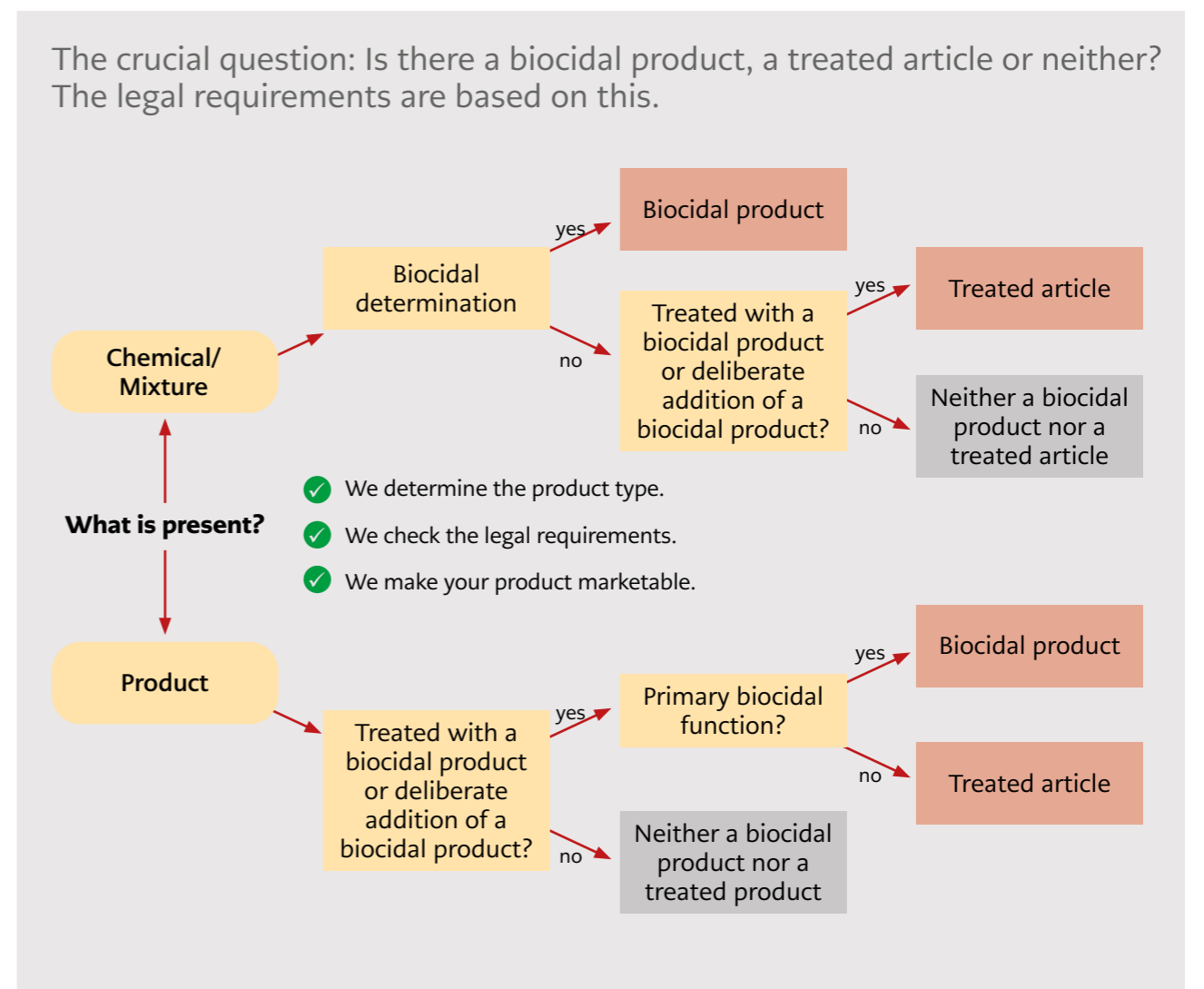
A Special Care: Treated Articles

The new edition of the BPR that has been in effect since 2013 also regulates the placement of treated articles on the market. They include chemicals, mixtures, or products that were treated with one or more biocidal products or to which one or more biocidal products were deliberately added. We can let you know which biocidal products are authorized and how they are to be labeled.

Please note that the BPR considers treated products with primary biocidal functions as biocidal products that must be authorized accordingly (see graphic).
