We Make Your Cosmetics Marketable

As a manufacturer, distributor, or importer of cosmetics in the EU, you are subject to the requirements of the of Regulation (EC) No. 1223/2009 on cosmetics (EU Cosmetics Regulation). We can handle the safety assessment for a cosmetic product and its entry into the Cosmetic Products Notification Portal (CPNP). In the United States, the regulations of the Federal Food, Drug and Cosmetic Act (FD&C Act) and 21 CFR Subchapter G – Cosmetics apply. We provide advice on the rules that apply in the United States and in the EU and can tell you which ingredients are allowed in specific locations and which may be used only with restrictions.



UPHOLDING PRODUCT SAFETY – Ensuring Marketability

Cosmetics become marketable only when they meet the requirements of country-specific cosmetics regulations. As a manufacturer, distributor, or importer in the EU, you are obligated to meet certain labeling, inspection, and notification requirements. We would be happy to perform these tasks for you and provide comprehensive advice about the legal security of your cosmetic products.

Germany and the EU

Our experts know how to bring your product to market safely. To make sure that happens, they perform all the tasks required by the EU Cosmetics Regulation. And although you don't have to apply for registration, you, as a manufacturer, distributor, or importer, must guarantee the harmlessness of your products and prove it by means of a safety assessment and a product information file. We can undertake all these measures for you.

United States

When you want to market your products in the United States, note that the EU and the United States define cosmetics differently. Many products sold as cosmetics in the EU are considered drugs in the United States: Sunscreens and dandruff shampoos are good examples. And unlike the situation in the EU, tattoo inks are considered cosmetics in the United States. The legal requirements of the FDA and the Federal Food, Drug, and Cosmetic Act (FD&C Act) apply to cosmetics as defined in the United States – including imported products. We can advise you about the specific labeling obligations created by these regulations and about any other measures needed to ensure the marketability of your products in the United States.
